#### WHO IS KINETIC GPO?

Kinetic GPO is a cooperative purchasing organization established for Broader Public Sector and MASH entities across Canada, with the specific purpose of reducing procurement costs by leveraging the purchasing power of group buying and saving members time by simplifying steps to procure. All Kinetic GPO contracts are awarded using a competitive solicitation process consistent with Chapter 5 of the Canadian Free Trade Agreement (CFTA) and other international trade agreements, including the Canada-EU Comprehensive Economic and Trade Agreement (CETA), as well as the Broader Public Sector (BPS) Procurement Directive.

Group Purchasing Organizations (GPOs) are widely used in Canada, especially in the medical health, municipal and education sectors.

### WHO CAN USE KINETIC GPO'S CONTRACT RFSO 24-06 ROOFING SUPPLIES AND SERVICES, WATERPROOFING AND RELATED PRODUCTS AND SERVICES?

### ANSWERS TO FREQUENTLY ASKED QUESTIONS

## WHAT TYPE OF WORK CAN BE PERFORMED UNDER THE CONTRACT?

All aspects of the roof and building envelope are included within the contract. Roof services include diagnostics, roof repairs, roof restoration and roof replacements for both low-sloped flat roofs and sloped metal/shingled roofs. Additional products and services include sustainable roofing systems, building envelope restorations, building envelope energy audits and air assessments, indoor air quality and HVAC assessments, leak response, disaster response maintenance services, construction services and rooftop safety solutions. There are three procurement options: 1) Materials can be purchased directly with precompeted material pricing, 2) Material and services can be sourced utilizing our turnkey solution, or 3) Materials and labour can be sourced directly via a qualified contractor through our Contractor Network program.

#### IS IT LEGAL?

YES. All Kinetic GPO contracts are awarded using a competitive solicitation process consistent with Chapter 5 of the Canadian Free Trade Agreement (CFTA) and other international trade agreements, including the Canada-EU Comprehensive Economic and Trade Agreements (CETA), as well as the Broader Public Sector (BPS) Procurement Directive, the New West Partnership Agreement (NWPTA), the Atlantic Trade and Procurement Partnership (ATPP), and other relevant trade legislation.

The Canadian Free Trade Agreement has been in force since July 1, 2017 and most of the provisions of the Comprehensive Economic and Trade Agreement have been in force as of September 21, 2017.

The Canadian Free Trade Agreement recognises "Group Buying" as a valid way for public sector organizations to procure goods and services. The following language is from Article 504.5-9: Scope and Coverage found on Page 40 of the CFTA:

#### **Buying Groups**

- 5 A procuring entity shall ensure that any procurement conducted through a buying group is carried out in a manner consistent with this Chapter.
- 6 A buying group shall publish a notice for each procurement. The notice must list the participating procuring entities and must outline the potential for other procuring entities to participate in the procurement after the procurement instrument has been put in place.
- 7 A procuring entity shall publish a notice of its participation with the buying group at least annually on one of the tendering websites or systems designated by its Party. That notice shall direct potential suppliers to the buying group tender notices website if it is different from its Party's tendering websites or systems.
- 8 Subject to Article 503.1, when a procuring entity procuring through a buying group has little or no control over the procurement process, it is not required to ensure that the procurement is consistent with this Chapter.

A member's ability to use Kinetic GPO's contracts depends on the member's local policies, guidelines and regulations. Some entities feel that Group Buying is like using a Standing Offer or Master Agreement from their province or federal government.

All Kinetic GPO contracts are awarded using a competitive solicitation process consistent with Chapter 5 of the Canadian Free Trade Agreement (CFTA) and other international trade agreements, including the Canada-EU Comprehensive Economic and Trade Agreements (CETA), as well as the Broader Public Sector (BPS) Procurement Directive, the New West Partnership Agreement (NWPTA), the Atlantic Trade and Procurement Partnership (ATPP), and other relevant trade legislation.

Using this contract will save members time and money compared to issuing their own bid because the bidding has been done for you. It allows the project to start faster because you don't have to prepare the bid documents, advertise for several weeks and evaluate bid responses. The contract also brings quality, local, best-inclass contractors to the job, thereby virtually eliminating expensive contractor-initiated change orders that occur on most traditionally bid jobs.

# WHY WOULD A KINETIC GPO MEMBER USE THIS PROGRAM AS OPPOSED TO TRADITIONAL BIDDING?

Traditional bidding takes a considerable amount of time and resources that a member may not have available, which may require contracting the bid process to a third party. A traditional bid requires writing detailed specifications, the creation of an RFP, advertising for several weeks and expertly evaluating the bids submitted to determine which bidder meets the criteria established in the bid documents. Accepting low bids without first evaluating responsibility and responsiveness may result in poor performing contractors, shortcuts, inferior quality and change orders. With the Kinetic GPO contract, these problems are avoided, as the roofing bid has already been competed and competitively awarded.

# WHAT IS THE CANADIAN COOPERATIVE CONTRACTOR NETWORK?

When using the Kinetic GPO contract RFSO 24-06 for ROOFING SUPPLIES AND SERVICES, WATERPROOFING AND RELATED PRODUCTS AND SERVICES, Kinetic GPO members are offered the unique ability to work compliantly with their preferred roofing and weatherization contractors who qualify.

The Canadian Cooperative Contractor Network Program, administered by Tremco, allows members of Kinetic GPO to award work to pre-approved, In-Network Contractors who meet a range of qualifications, including quality, past performance, financial stability, safety and insurance requirements.

#### **ARE PERMITS INCLUDED?**

YES. WTC and their subcontractors are responsible for securing all permits.

### WHAT DELIVERY METHODS ARE AVAILABLE?

Through the contract, you can choose to procure solutions three ways:

- 1 Full turnkey labour and material solutions with project oversight by WTC General Contracting.
  - This is a labour and material solution
  - WTC is the prime contractor and assumes all risk
  - Utilizes best-in-class local subcontractors
  - Delivers the highest level of control over all aspects of your project
  - Includes project management and onsite supervision
- 2 Work with a local approved contractor through the Canadian Cooperative Contractor Network.
  - This is a labour and material solution
  - Your preferred In-Network Contractor is the prime contractor
  - Gives you the ability to select best-in-class local contractors to propose work under the contract
  - Reduces risk of low bid project quality issues
  - Tremco administers the program
- 3 Material Only Solution.
  - No labour component; labour bid by public entity
  - Similar to traditional bid process
  - Dependent on low bid labour

### DO KINETIC GPO MEMBERS HAVE TO USE THIS ROOFING CONTRACT?

No. It is an option. Members who conduct their own bid should consider the costs of bid preparation, specifications, advertising, bid evaluation, change orders, as well as job site and safety coordination. In addition to increasing the project cost by 10-15%, the member is not guaranteed a quality contractor. And if an alternative is bid, there is no guarantee it is an equivalent.


